

### **Data protection policy:**

1. The European Fascial Distortion Model Association (hereinafter referred to as EFDMA for short) takes the concerns of data protection very seriously and wants to ensure that the privacy of users and prospects as well as the security of personal data of the users of the EFDMA website ([www.fdm-europe.com](http://www.fdm-europe.com)) is guaranteed.
2. Collection, processing and use of user data:
  - a. As a non-registered visitor/user, it is possible to use this website without providing personal data. As an interested party and viewer, you can visit the EFDMA website without having to say who you are. No personal data, that arise when you visit our website, will be requested or stored unless you give your express consent.
  - b. If you voluntarily give us your personal data on the following pages when contacting us or registering (e.g. name, address, e-mail addresses), you can be assured that this data will be treated as strictly confidential and protected by appropriate security systems.
  - c. The information you provide will be processed in accordance with the current General Data Protection Regulation. Your data will not be disclosed to third parties without your explicit consent.
  - d. The EFDMA uses cookies to make this website more user-friendly and secure and to enable you to use all the features of this website. You can deactivate these cookies, a window will appear immediately after the page is accessed. We use the "Matomo" tracking tool to analyze and statistically evaluate the use of the website. Cookies are used for this. The information obtained about website usage is transmitted exclusively to our server and summarized in pseudonymous usage profiles. We use the data to evaluate the use of the website. The data collected will not be passed on to third parties. The IP addresses are anonymized so that they cannot be assigned to individual users. Furthermore, the operating system, the browser and the type of device (e.g. mobile device or stationary device) are recorded. You can deactivate "Matomo" in the "[Imprint](#)" of the EFDMA Website.
  - e. Personal data (e-mail, name, title, grade, address, telephone number and voluntarily date of birth) are only collected from registered users (e.g. members) if you expressly make them available to the EFDMA, for example when registering to membership. This data is processed and stored insofar as this is necessary for the services used by the specific user and for the administration and support of the members and the pursuit of the association's goals. By entering your data in the fields provided, you agree to the publication in the FDM practitioners search on the EFDMA website. You undertake to keep your data up-to-date at all times and to notify us of any changes to your data immediately.   - f. In accordance with the legal requirements, data is only stored by us in personal and electronic form for as long as is necessary to achieve the corresponding processing processes. The data will then be deleted or only kept in non-personal form.
  - g. You have the right at any time to obtain free information about your personal data stored at the EFDMA and the purpose of the data processing. Furthermore, you have the right to correct, block or delete this data.
  - h. EFDMA uses appropriate technologies to send and analyze emails. The EFDMA informs its members in these emails about all association matters (various changes, innovations, resolutions of the General Assembly, changes to the statutes, the membership fee, member discounts, association events, etc.).
  - i. In addition, your data may be used to the extent permitted by law for postal mailings of information about offers, content and services. You may revoke the consent given to EFDMA at any time with future effect. If you have subscribed to the newsletter of the EFDMA, you can also claim the revocation by clicking on the unsubscribe link contained in the newsletter. You will receive a confirmation for the deregistration.
  - j. EFDMA does not send unsolicited e-mails for purely promotional purposes.
